As the recipient of Federal financial assistance, you are required to expend Federal funds in accordance with 2 CFR 200. Do you know the procurement thresholds, proper procurement methods, cost reasonableness and is your agency's procurement policy up to date? This session will offer guidance and tips for staying compliant.

CDBG-CV Monitoring

Carla Spradlin, HUD CPD, CARES Act Representative

Carla Spradlin has been a CARES Act Representative since 2020. She provides technical assistance and support to Region V and VII CDBG-CV grantees in ten midwestern states including Michigan. Carla will provide an overview of the CDBG-CV monitoring process including the specific monitoring exhibits used to review the PPR tieback, duplication of benefits, national objective, and activity eligibility requirements. She will also address the requirements for Special Economic Development projects, applicable to



both CDBG-CV and CDBG activities. Carla may be joined by grantees who have recently completed a CV monitoring. Carla will be presenting remotely; however Cindy Vails, HUD Senior Financial Analyst and grantee representatives will assist in person to create a dynamic session including discussion and Q and A. MCDA will solicit questions from members later in the summer to have answered during the session.

Roofing Issues

Sven Harrison, City of Jackson

Sven Harrison has been working for the city of Jackson as a building inspector, rehab offices, and code enforcement officer for the last 11 years. Prior to his time at the city, Sven was a general contractor working in remodeling and new construction. Rehab officials need to determine what needs to be inspected on a roof in order to determine what work needs to be completed. This session will include important information that will be a great benefit to rehab professionals and include topics such as how to re-roof, install flashing especially around chimneys, ice and water barriers, and venting.

Navigating the Relationship Between Housing Commissions and Municipalities

Excerpts from federal and state enabling legislation, local ordinance, the Annual Contributions Contract and the Cooperation Agreement will help clarify the historical relationship and connection between Michigan Housing Commissions and the local unit of government. HOTMA, Part 1

Eric Oberdorfer, NAHRO Director, Policy and Program Development

HUD is currently in the process of implementing the Housing Opportunity Through Modernization Act of 2016 (HOTMA). Provisions in sections 102, 103, and 104 of HOTMA will impact income reviews, asset limits for tenants, and over-income residents in public housing. This session will walk attendees through everything you need to know about the HOTMA sections 102, 103, and 104 rule to make sure their agency is prepared to implement these new provisions.

CDBG Financial Management Best Practices

Cindy Vails, HUD CPD, Sr. Financial Analyst, Terra Linzner, Homelessness Solutions Director, City of Detroit and Stacy Conwell-Leigh, Homlessness Program Analyst II, City of Detroit

Cindy Vails is a financial analyst for HUD's CPD Office. Cindy conducts financial monitoring visits and is well versed in the section of the Federal Register that guides financial practices and decision making for HUD programs, 2.CFR.200. Cindy will present best practice information to ensure grantees have a strong foundation of financial knowledge. Topics will include the use of grant agreements, checking for suspension and debarment, maintaining written procedures and internal controls, recording procurement histories including audit procurement, and accurately reporting expenditures and financial performance. Cindy will be joined by CDBG grantees who will provide their working knowledge of the regulations and methods for satisfying some of the requirements in the Federal Register. This will be an in-person session with time for Q and A. MCDA will solicit questions from members later in the summer to have answered during the session.

Bathroom Waterproofing

So, you thought the installation of hardibacker was good enough? Well, it's not and when it comes to rehabbing rental and primary spaces crucial steps cannot be missed. Mold and mildew are ugly sights to see, but what if you can't see it but you smell it? How does that happen? Why does that happen? It's more common than you think. Structural damage can ensue when bathrooms are not watertight! We will dive into the do's and don'ts when renovating bathrooms and touch on other areas of the home that are prone to water damage by way of bad installations.

CDBG Overall Best Practices

- Compliance: Ensuring that labor standards, including Davis-Bacon prevailing wage rates, are applied correctly and consistently across different projects and contractors
- Technical Assistance: Provide technical assistance for administering HUD programs and answering questions participants may have
